THE QATAR DISCONNECT

Intelligence report – 2016 - During a meeting with the prime minister of an EU country, the intelligence services director shared concerns about serious adverse effects on the financial sector caused by future international incidents concerning Qatar.

SECURITY THREAT IN THE GULF REGION!?

Likely

During the World Cup in **Qatar**, terrorists are likely to try to carry out attacks in the **Gulf region!** Attacks could be indiscriminate, including in places visited by foreigners, residential compounds, and public spaces such as restaurants, hotels, beaches, and shopping centers.

Security experts say the risk of a large-scale attack in Qatar is low. Of course, that was determined by their (limited) time frame, scope and focus.

This will be the best surveilled World Cup ever.

Facial and tech recognition is partially sufficient but not for threats cultivated for many years. The authorities will monitor crowds, from CCTV cameras to communication networks, including covertly monitoring behavior and indicators. They have a lot of technology, some specifically for the World Cup process.

This may be the last FIFA World Cup ever.

However, most of the perpetrators are already positioned for months or years. They are fully integrated and unobtrusive. They work in the hospitality industry, transport, IT, security, ports, and airlines, even in the ecosystems of competing football teams! They won't stand out.

International security support

Military resources, security personnel, and other types of support, an internationally-assisted security blanket will make any sophisticated attack unlikely.

Planners for al Qaeda and ISIS have sources with military and intelligence resources, turning most security forces into a liability. Infiltrated and outperformed by long-term planning and preparations for sophisticated, coordinated attacks.

During the World Cup events, the operational setting of (American) military presence, refugee camps, and a Typhoon Squadron is a liability that terrorists could use.

Security pact of 13 nations

France, Turkey, and the USA have also sent a range of support. Ankara has pledged to send riot police, sniffer dogs, and bomb disposal experts to the games. Pakistan has committed 4,500 troops to serve as security.

Turkey and Pakistan, whose intelligence services MIT and ISI facilitated affiliates and offshoots of al Qaeda ISIS in Syria, Iraq, Afghanistan, and elsewhere. How many are part of the security pact?

Joint operations center

The US has also made extensive arrangements, with Washington's Diplomatic Security Service saying it has 'numerous special agents and analysts at a joint operations center in Qatar's capital Doha.

Sharing intelligence on the level of diplomacy is a liability.



THE FRIEND OF MY ENEMY IS MY ENEMY

Enemies from different levels and scopes

Like other western populations subjected to terrorism, the good willing Qatari cannot imagine that someone out there hates them so much. At the same time, they do their utmost best to show off their positive input to the world. But ideological and criminal enemies are out to destroy the leadership and damage Qatar's geopolitical (oil, gas, financial) strength and international business relations.

USA, Russia, and China

Next to threats by Iran and North Korea, the Whitehouse, the State Department, and its often opposing industrial complex portray Russia and China as ideological, industrial, and criminal enemies.

Except for Special Operations, officially, the Whitehouse does not want a war with boots on the ground, but the industrial complex backed by Congress does. Therefore proxies have become the preferred instruments of war. Proxies have been perfected and independently used by industries of many nations.

The use of proxies, such as extremist political movements and terrorist groups, is on the rise where Russia's oil and gas (pipelines) and the Chinese BRI pass thru.

Reasons for friend or enemy (of the USA)

The choice of enemies can differ greatly, even opposing, regarding a government or its secret intelligence services and industrial complex. Not only governments change but also the geopolitics of secret intelligence services and the composition of an industrial complex.[..]

[..] of course, in the case of its BRI and BRICS, China has many friends. And on the industrial economic level, for example, e.g. Iran, Pakistan, Saudi, and Qatar are business friends of China and thus strategic enemies of the US intelligence services, economic threats to the US government, and like Russia, in competition with the aggressive US LNG industry.

Bridge the gap between the western and Arab worlds, Qatar World Cup 2022

Qatar launched its bid to stage the World Cup finals in 2022 on Sunday, May 17, 2009, saying that: Its tournament vision would help bridge the gap between the western and Arab worlds.

The Muslim Brotherhood

Qatar is supporting the Islamic "ideology" of the Muslim Brotherhood, provoking Saudi Arabia and the UAE, who consider such groups an imminent existential threat. Qatar supported the Muslim Brotherhood government in Egypt and has warm ties with Iran. Qatari are funding humanitarian and development NGOs that support Sunni militia and Palestinian Hamas. Escalating tensions in the Arab Gulf could lead Qatar closer to Turkey or Iran. Qatar has continued its practical engagement with Israel.



The Shadow Where Crime Becomes Ideology - Al Qaeda ISIS

Al Qaeda projects itself as an organization fighting for the greater good. In reality, it is nothing more than a name that different groups (can) hide behind and attach themselves to the Al Qaeda 'brand' or its PR infrastructure.

Not only is Al Qaeda very good at PR, but they also piggyback off of other movements to gain attention and new members.

Proxies - instruments of war

It does not take a brilliant mind to think of ways this system can be exploited by organizations with enemies and highly determined competitors. If any of those enemies were to attack their competitor, they would not have any good way of doing that without outing themselves as the culprit.

This is where Al Qaeda comes in. Thus, diverting blame from themselves and onto largely unsuspecting groups of people who flock to the Al Qaeda 'ideals'. These people, or scapegoats rather, are the ones that read about (these Al Qaeda) 'attacks' and decide to join in by connecting to their network and launching attacks on Al Qaeda targets. They are the ones who are eventually caught, leaving the actual and more skilled/intelligent perpetrators in the dark behind the Al Qaeda shadow where crime becomes ideology!

This then leaves the imagination to wander. Was an attack the work of a competitor? Foreign Intelligence Service? Terror group? Or was it just a group working under the Al Qaeda name in the past?

To answer this question will take someone more **in the know**.

'In The Know'

This access was developed to create a high level of trust in face-to-face meetings.



Primitive militia holed up in the wilderness or jungle?

Terror attacks are often portrayed as an incident with little preparation or coordination, the image of the Islamist group as a primitive militia, disenfranchised, marginalized, and estranged from society, holed up in the wilderness, jungle, or backstreets of the cosmopolitan cities. Dreaming about the mission and vision but lacking the capabilities and skills to plan attacks that meet a strategy's and military doctrine's requirements.

Or professionals executing international plots?

Only when more attackers seem to be able to cause carnage that claims the attention of international media for days in a row and murder people in plain sight. Only then does one start to wonder about the level and coordinated planning those attacks have, and if such a scale of preparation can be detected and prevented.

Al Qaeda "The Base", detected but never eradicated

Al Qaeda "The Base", as in connections that go back to the 90s and developed into the past decade. Building informal relationships and human networks, one of the most important of which was formed around bin Laden in the 1980s and 1990s.

Counter-terrorism operations launched after 9/11 show that detection takes an enormous investment in Techint and deep cycle undercover operations. Traditional mechanics of terror groups proved no longer effective due to the advanced monitoring possibilities of the intelligence services (NSA, Echelon) and widely infiltrated Mosques. The operations were successful but did not go unnoticed, forcing 'The Base' to change methods, minimize their use of infrastructure and move their leadership from Europe to less technologically advanced countries, thus staying under the radar of government agencies.

Al Qaeda's "The Base" was never eradicated because the WOT was the WOTF "War On Terror Figureheads" with a focus on thought leaders like Usama bin Laden and the AfPak region. **Allowing unchecked growth of the international funding and support network.**

The complexity of cross-continent high-profile attacks by Al Qaeda Affiliates

Anti-money laundering investigations (Ultrascan-AGI, 2007-2013) link the initial funding to support more complex cross-continent attacks by Al Qaeda's affiliates. The new (re-) acquired organizations like LeT, Al Shabab, Al Nusra, Boko Haram, ISIS, and groups that have not yet (re-) captured the eye of the global media today. For example, the [Mumbai attacks ended at the Taj Mahal hotel](#), the [UN building in Abuja](#), the [US embassy in Benghazi](#), and the [Westgate shopping mall in Nairobi](#).

The complexity is then defined by (preparatory and coordinating) acts abroad, foreign participation, and professional knowledge of security measures at the target.

What does that look like let's have a view to a kill and map the international communications in the days leading up to such a high-profile terror attack in Dakar, Senegal.

A context of intelligence operations

The secret services are the only real measure of a nation's political health. The one true expression of its subconscious

Since 2007 the intelligence services prepared for a significant shift in real US geo-policy, military power, and intelligence.

An essential part of that shift, leaving war zones and decreasing its military presence in partner countries, occurs. Allocated financial DoD resources show that what remains are substantial special operations (US-SOCOM) [...] a prioritized global monitor function facilitated by big tech. [...]

Good stories spell the end of an era

The Anglo-American security and intelligence relationship from the Second World War to the present day roughly divides the world between them and exchanging the material recorded. The US and UK 'saved themselves a great deal of money and trouble and continue to do so in the Five Eyes intelligence alliance comprising Australia, Canada, New Zealand, the United Kingdom, and the United States. The Nine Eyes Denmark, France, The Netherlands, and Norway participate as third parties. And Fourteen Eyes is an arrangement between SIGINT agencies.

Non-Western intelligence-sharing alliances include the Shanghai Cooperation Organization between China, India, Kazakhstan, Kyrgyzstan, Pakistan, Russia, Tajikistan, and Uzbekistan.

Intelligence is no longer centralized

The alphabet soup has been politicized for decades and should not be trusted by anyone. Most of these organizations have become political pawns serving the interests of one party or another. As politics has "unwittingly" become part of transnational organized crime, yes, it is very much Third World and wholly unacceptable. Also, the scope of Special Operations and Classified Programs is no longer limited to foreign soil.

The Central and the Defense Intelligence were prohibited from working inside their home countries, but nowadays, they use their instruments as if it was on foreign soil. A long time ago, they could say they only worked inside their country in the Diaspora of other countries, like Somalia, to use it there. Or to make money without oversight, with fraud and other crimes. Every time they said it was for a good cause, but now the limits are gone. They work inside their homelands to control and influence the population with a broad scope of fear narratives, visions, and missions.



NOTES

The end of Pakistan and Israel as we know it

(1)Both were created after WWII, (2)as nuclear powers, (3)in the name of religion, (4)by the same creators, (5) as a source of tension in the region, and (6)with mighty professional armies.

The US and UK can no longer fund the trillions for Pakistan and Israel and will leave them at their perils. While fighting for their existence, both will cease to exist as we know them today. After the wars, one might surface stronger, but there is no doubt it will be at a cost to the population.

Strategic realignment of Marine forces

There has been a strategic realignment of Marine forces focusing on China, decentralization of both force and command structure, and enhanced lethality. Marines will be deployed throughout the Pacific region.

AML and China

In recent years the intelligence projects covering Chinese subjects intensified. Initial AML investigations revealed money laundering techniques to hide beneficiaries of significant real estate investments in western Europe. These projects are deep cycle, disclosing AML information about Chinese business networks to task a risk mitigation service. 2022 active [...] UNDISCLOSED
